

Multi-Purpose Hall Policy

Background

The Old Boys Club (OBC) has pledged to fund more than half of the construction of a multi-purpose hall to host events and programs that enrich student life at Alliance High School.

AHSEF facilitates the collection of funds from U.S.-based supporters who would like to contribute to the project, and supports transparent reporting on funds received and disbursed.

Initiating the framework

Based on pledges from U.S.-based Old Boys and friends of Alliance High School, AHSEF maintains a designated Vanguard account for collecting and disbursing U.S.-based contributions for the Multi-Purpose Hall project.

Giving to AHSEF (Multi-Purpose Hall Fund)

USA residents' gifts to AHSEF are tax deductible since we are a 501(c)(3) tax-exempt organization. Please designate your gift to the Multi-Purpose Hall Fund (Vanguard Account # 1596650) using one of the methods below.

Investment policy

Funds designated for the Multi-Purpose Hall are invested in a money market fund at AHSEF’s investment service provider (Vanguard) under Vanguard Account # 1596650, consistent with a capital-preservation approach while funds are being raised for project disbursements.

Disbursement of funds

On a quarterly basis, AHSEF will disburse project funds to the AHS Endowment Fund Trust in Kenya for administration and payment to the project, subject to available balances and board oversight. To minimize transaction costs, AHSEF will generally target disbursements of at least \$1,000 and will ensure the Vanguard account maintenance threshold is met before initiating transfers.

Promotion and fundraising

Promotion and fundraising remain within the ambit of the OBC and Multi-Purpose Hall project committees. AHSEF limits its role to facilitating collection, disbursement, and reporting of funds.
